IMPORTANT NOTES TO APPLICANTS - REGISTERED STUDENT

- 1. A person who satisfies the following conditions may register as a Student of the Institute:
 - (i) is aged 18 years or above, and
- (ii) holds required level of education, or an equivalent qualification recognised by the Council of the Institute; or
 - (iii) has completed or has been fully exempted from the 'examinations of Certified Tax Manager (CTM) or (iv) is studying in an accountancy or business related undergraduate programme recognised by the Council.
- 2. At the discretion of the Council, a person may register as a Student, if he/she is aged 25 years or above, and possesses not less than five years' experience in the field of taxation (a "mature student").
- Copies of CNIC / Passport, academic certificates (and letters of employment in the case of a mature student) must be attached to this application and will be kept by the Institute for the purpose of processing and maintaining his/her registration as a student. The copies must be attested from the member of a recognise professional body.

- 5. The name of a student whose annual registration fee is six months in arrear will be removed from the Register of Students and he/she will not be eligible to sit for the Institute's Examination.
- 6. A student who has passed all the examination for admission as a Member shall be conferred the designation of the Institute. The one who has not yet completed the prescribed years of taxation experience to qualify as a Member may continue on the Register of Students on such conditions as the Council may prescribe.
- 7. The Institute's Code of professional Conduct sets out the fundamental principles and standards of behaviour that all students must follow. Please read through the Code of Professional Conduct before making your application.
- 8. The Institute reserves the right to use the data so collected for statistical research and analysis, providing members' services and for other internal uses.
